

Extranjeros con situación irregular en España

These are foreigners who are not in a situation of residence (temporary or long term) or stay (stay in Spanish territory for a period of time longer than 90 days). In these cases the foreigners will be deported from Spanish territory for not staying legally.

Generally the expulsion of the irregular foreigners happens when they access the grade 3 regime or if they have faced three quarters of their sentence if the sentences are 6 years or more.

SPANIARDS IN REGULAR STATUS

Release grant

Monthly financial assistance provided (for a maximum of 18 months) to persons released from prison who have been deprived of their liberty for a period longer than 6 months. It's meant to let interns to **subsist until they find a job**.

Unemployment benefit

People with sentences longer than 6 months can be granted this benefit during 18 months. They must **be unemployed and not have enough economic resources**.

Active insertion income

Income for unemployed people not entitled to contributory benefit or unemployment benefit. The application **must be requested at the Servicio Público de Empleo Estatal (SEPE)**, requesting a prior appointment..

Minimum living income

Income for people in a situation of vulnerability.
The request can be filled through Sede Electrónica de la Seguridad Social (<http://sede.seg-social.gob.es>).

DNI Renewal: Must have prior appointment

Application for a health card

Personal document that grants access to public health systems. The requester must have:

- Social Security affiliation number
- If beneficiary rights is requested: must be brought documentation proving the relationship with the beneficiary
- When registered with the Social Security: Must request the card in the nearest healthcare center

Community of Madrid Transport Pass

Grants access to metro, light rail, short and medium distance train, urban buses, suburban buses and long distance buses.

Cell phone usage

- In case that a phone was not owned before facing prison the person must go to a mobile phone store and request a new number and phone.
- In case of having a phone before facing prison but not disposing of the SIM card or the phone the person must request a SIM card duplicate.
- In case of not having enough resources to buy any of the previous items the person can access telephone and Internet services visiting call shops.

Bank Account

Necessary to access any income aids. The bank account grants access to the income and lets the user withdraw the money when necessary. In case of not having a bank account it will be necessary to open a new one via online or in a bank.

Shelters

Social Service of Municipal Attention to Social Emergencies: City of Madrid

By dialing 112 you can access SAMUR SOCIAL to have information of possible options to sleep for people that left prison and don't have a place to sleep in the first days.

Social Emergency Service: Community of Madrid

It is accessed by calling 112. It's a service meant to people or groups of people in a vulnerable situation or crisis that can't handle themselves and need urgent intervention.

SPANIARDS OVER 52 YEARS OLD

Allowance for people over 52 years of age and early retirement

Requires:

- Be unemployed
- Not to have the condition of discontinuous permanent worker
- Be 52 or older in the date of the request
- Be registered as a job seeker for one month after the exhaustion of the unemployment benefit you were receiving
- Fulfill the activity commitment
- Not have own incomes above 75% of minimum wage

Ordinary retirement

Requires:

- Have contributed at least 15 years
- Have a certain age, determined by the years contributed
- Must be affiliated with Social Security
- Must have finished a career

Residential Homes or Day Centers

- Residential Homes in Madrid (City): Can be found in every district (Arganzuela, Centro, Usera, Carabanchel, Latina, etc.)..
- Residential Homes in Madrid (Community): Like the ones found in Parla, Mostoles, Pinto, Puente de Vallecas, Aranjuez, San Blas, San Cristobal, San Fermin...)
- Temporary Stays at Residential Homes in Madrid (Community): They are exceptional stays, due to certain family circumstances of a transitory nature that prevent the family from dedicating the necessary attention to their elders due to the person's convalescence. The maximum stay duration is 2 months
- Weekend Day Center in Madrid (Community) For elders of 60 years or more, they are day centers to spend the day from 10:00 to 20:00:
 - Fundación Reina Sofía Alzheimer (C/ Valderrebollo, 5).
 - Mirasierra (C/ Portera del cura, con vuelta C/ La Masó).
 - Peñuelas (C/Arganda, 9-11).
 - Villaverde (Carretera de Villaverde a Vallecas, 38).
 - Parque Coimbra (Avda. Los Sauces, s/n).
 - Parque los Frailes (C/ Parque los Frailes, 12)

FOREIGNERS

Legal foreigners in Spain or foreigners that commit a crime in Spain but have a residence permit

The residence permit is lost at the moment the foreigner is sentenced to more than one year in prison. When he/she is released from prison, he/she has to renew the documentation. This process is complicated by the existence of a criminal record.

Cancellation of the criminal record; for this purpose, the following requirements must be met:

- The sentence must be faced.
- Once the sentence has been faced must wait from 6 months to 10 years depending on the sentence
- At the moment of reoffending, the computation of the sentence is restarted.

Procedure for expungement of criminal records:

- An express request for cancellation is filed with the Ministry of Justice. Specifically, a form is filed with the Central Registry of Convicted Persons.

Personal information that must be attached:

- Residence permit
- Certificate of completion of sentences issued by the competent court or tribunal competent.

Appeals against a decision denying renewal of a residence permit:

- Appeal for reconsideration: before the Immigration Office; the deadline is one month.
- Appeal (alzada): to the Government delegation or subdelegation.
- Contentious-administrative appeal: before the Contentious-Administrative Courts; a 2-month period.
